Ms. Karolina D'Cunha

Deputy Head of Unit "Sustainable Production, Products & Consumption" in the European Commission's Directorate General Environment.

Karolina was part of the Commission's team that prepared the Circular Economy Package adopted in December 2015, and her team is now responsible for the implementation of the parts of the strategy that deal with sustainable products, production and consumption.

Prior to her current job, she was responsible for the implementation and development of waste management policies for over ten years. She was, amongst others, responsible for the implementation of the Waste Framework Directive - the cornerstone piece of European legislation on waste -, as well as legislation on end-of-life vehicles, packaging, electrical and electronic equipment, and other waste streams.

In 2013, she concluded negotiations on the Ship Recycling Regulation and the review of the Packaging Directive which restricted the distribution of single-use plastic bags in supermarkets.

Mr. Markus Wiesner

EFIC President and CEO Wiesner-Hager Möbel GmbH

Markus is CEO of Wiesner-Hager and thanks to his leadership the company has become one of the leading European office and property's producers with an export rate of 56%. The company employs over 300 people throughout the Group. In the past fiscal year 2016/17 the sales amounted to 37 million euros.

In addition to his entrepreneurial professional activities, Markus has been holding leading positions for many years as a representative of companies' interests. He has been Austrian Wood Industries' spokesman for environment for ten years and has also chaired the Austrian furniture industry for ten years.

Since 2012 he has been working as President of the EFIC, the European Furniture Industries Confederation based in Brussels.

Mr. Carsten Wachholz

Senior Policy Officer on Resources Conservation and Product Policy European Environmental Bureau (EEB)

At the EEB Carsten is responsible for monitoring the implementation of the EU Circular Economy Action Plan. He advocates for the EU to match its rhetoric on resource efficiency with ambitious proposals in the areas of eco-design, labelling and related fields of product policy.

Before coming to Brussels, Carsten was deputy head of the department for environmental protection at the headquarters of German NGO NABU, where he worked on climate change, energy policy and sustainable development. He also gained expertise as a consultant in facilitating stakeholder communications, public participation and conflict resolution.

The EEB is Europe's largest network of environmental citizens' organisations. It represents around 140 civil society organisations from more than 30 European countries.

Joan Marc is based in Brussels where he coordinates the work of Zero Waste Europe.

He has been a leading voice for Zero Waste in Europe since 2007, dramatically increasing the visibility and policy impact of Zero Waste efforts in this time. He is a regular keynote speaker in many industry and NGO meetings in Brussels but also at local level as well as internationally. In 2015 he has authored the Zero Waste Case Study "The Story of Contarina" and "The Story of Gipuzkoa" as well as the book "Zero Waste – How to reactivate the economy without trashing the planet".

With training in Economics and Development Cooperation, he has more than 10 years of experience working with governmental and non-governmental organisations in the field of good governance, new economics, social justice, and environment.
